4. Run ahead rule applies to actual runs scored.
5. HOME RUN RULE: - 1 Home Run then progressive
6. GAME TIME IS FORFEIT TIME. Teams may start the game with 9, 10 or 11 players.
7. All games, until the Championship game, must go the regulation seven (7) innings or one hour and five (5) minute time limit, whichever occurs first. Championship and if necessary games shall go the regulation seven (7) innings with no time limit.
8. To speed up the game and allow the opportunity to play all innings, enforce a no touch base rule for all home runs.
9. All batters will start with a 1 – 1 count.
10. All teams are permitted to add three (3) players as follows:
  - a. Added players must be from the team's same division of play and the same or lower classification.
  - b. A pick up –player's previous year's re-classification ranking will be counted towards a reformed team's requirement to have a combination of fewer than five (5) players.
  - c. Pick up players must be submitted to the tournament director prior to the first game.
11. ASA uniform rules will not be enforced except that players are required to have a number.
12. Lineups must be available at least 10 minutes prior to game time and presented to the plate umpire. FIRST/LAST names and numbers are required. Home team must provide a scorekeeper up to the semi-final game. For the semi-final, championship, and if game the tournament director will provide the scorekeeper.
13. Protests will be settled on the spot. The protest committee consists of the Tournament Director and UIC. A tie will be broken via another umpire.

- 3) Run Differential - # of runs scored minus # of runs given up
- 4) Coin Toss - Best two out of three tosses
